

SECURE SHOPPING TERMS AND CONDITIONS OF SALE

THESE TERMS AND CONDITIONS OF SALE GOVERN YOUR PURCHASES OF PRODUCTS FROM DRIVN Industries, LLC (“COMPANY”). EVERY TIME YOU MAKE A PURCHASE ON OUR SITE, YOU ACKNOWLEDGE AND ACCEPT THESE TERMS AND CONDITIONS OF SALE. Every order you place through the Company will be deemed your offer to purchase our products. We may accept your offer either through an e-mail confirmation or through shipment of the items you requested. Our acceptance of each offer as specified is expressly subject to and conditioned on your acceptance of these (and only these) Terms and Conditions of Sale.

SHIPPING INFO

Please allow 24-48 hours for processing time.

For domestic orders we use the United Parcel Service (UPS). We ship from North Carolina at 2:00 pm processing all orders received by that time. Orders that are shipped using ground service characteristically take up to 6 business days depending upon the distance from North Carolina. We also use the United Parcel Service for all APO/FPO and P.O. Box packages that weigh less than one pound. Delivery time on these packages is up to 10 business days depending upon the distance from NC.

For all APO/FPO and P.O. Box address's over one pound we use the United States Postal Service (USPS). These orders can take up to 10 business days depending on the distance from NC.

For all international orders we give the customer the option to ship UPS Expedited which takes up to 5 business days for delivery and United States Priority Mail International which can take up to 10 business days. Duties and Taxes Orders shipping to destinations outside the United States may incur duties and taxes. If duties and taxes are imposed they are due at the time of delivery. Consult your local customs office for more information on your Country's duties and taxes.

You know we trust you, but all payments (including shipping and handling charges) must be received by Company prior to shipping – no C.O.D.s! We accept payment only by the following methods: Amex, Master Card, Visa and Discover. Please don't send cash or personal checks.

You cannot return or exchange your items if there is no noticeable defect or damages to the product, all sales are final unless the product itself is somehow damaged. Items that have been worn or washed will not be accepted for an exchange or refund. Write a detailed note, on your invoice explaining your return preference (refund or exchange). Once we receive your package we will make the necessary corrections and your package will be shipped back to you that day. It will take anywhere from 5-7 business days for you to receive it. CREDIT CARD SECURITY

We want you to feel safe and secure when you shop with us at www.DRIVNindustries.com. Please see our Privacy Policy to understand how we take care of your personal information. COMPANY SECURE SHOPPING GUARANTEE

The Company Secure Shopping Guarantee helps to protect you against unauthorized charges on your credit card. We know that it is important that you have the same confidence when you use your credit card online as you do when you order by telephone. That's why we offer the Company Secure Shopping Guarantee to help protect you from credit card theft or misuse. In the event that you discover unauthorized charges on your credit card within sixty (60) days after your purchase, please do the following:

2. If your credit card company: (a) determines that the charges were fraudulent charges resulting from your online purchases at Company, and (b) states that you will be held liable for any of the unauthorized charges, please contact us immediately as set forth below.

4. For security purposes, our fraud department will confirm receipt of your claim.
5. If we determine that the fraudulent charges resulted through no fault of your own, and that your credit card company has, nonetheless, held you liable for such charges (generally, they do not hold you liable for more than U.S. \$50.00), we will issue a credit to your credit card account up to a maximum of U.S. \$50.00 and send you a letter confirming such credit reimbursement.

FAIR CREDIT BILLING ACT

Here's why we have that \$50 limit. Thanks to the Fair Credit Billing Act, your credit card company or your bank can not hold you responsible for an amount higher than \$50 of unauthorized or otherwise fraudulent charges made to your credit card. Liability on a debit card can be greater, but check with your bank because most of them grant the same \$50 limit to debit cards.

CHANGES OR CANCELLATIONS

Any item additions, quantity changes, or specification changes made to orders we have accepted will generate a new acknowledgment for the entire order and a new scheduled shipping date. All sales are final; provided, however, item cancellations and quantity reductions may be made at least five (5) days before the scheduled shipping date. We may cancel any accepted order before shipment without liability, including, without limitation, if our credit card department does not approve your credit or if there are any other payment-related problems.

Shipping Info

For domestic orders, we use the United States Post Office 1st Class. We ship from North Carolina at 2:00 p.m., processing all orders received by that time. 1st Class characteristically takes from 3 to 8 days, depending upon the distance from NC.

COLORS

We display colors of our products on our site as accurately as we can, but the actual color you see depends on the accuracy of your own monitor, which we cannot guarantee. Products may vary slightly or not at all from the images on our site.

LIMITED WARRANTIES

We warrant that there will be no material defects in workmanship, materials, operation or finish for the products for one (1) month from the date of your purchase. This warranty will not apply to subsequent owners, or for defects due to fire, casualty, forces of nature, failure to exercise customary maintenance of the products, or the consequences of uses other than those for which the product was intended.

Our only liability under such warranties, whether in tort, contract or otherwise, will be, at our option, to repair or replace the products, or to refund the amounts paid for products returned to us. The parties to these Terms and Conditions of Sale each agree that the exclusive venue for any dispute between the parties arising out of these Terms and Conditions of Sale or pertaining to the subject matter thereof will be in accordance with the provisions of the Terms of Use. You irrevocably waive all rights to bring or participate in any class action suits or claims regarding the matters related hereto. If any part of these Terms and Conditions of Sale is unlawful, void or unenforceable, that part will be deemed severable and will not affect the validity and enforceability of any remaining provisions. These Terms and Conditions of Sale constitute the entire agreement among the parties relating to this subject matter.
